## Certificate of Analysis

Product: Goat anti-Human IgA + IgG + IgM, HRP Conjugate

Amount: 1.0 mg of lyophilized antibody ( $E^{1\%}$  at 280 nm = 13.0)  
(Product has been overfilled to ensure maximum recovery)

Label: Horseradish Peroxidase (HRP)

Form: Lyophilized

Purification: Affinity purified using solid phase Human IgA + IgG + IgM

Purity: Affinity purified antibody is  $\geq 95\%$  based on SDS-PAGE

Host: Goat

Immunogen: Purified Human IgA + IgG + IgM, whole molecule

Buffer: 10 mM Sodium Phosphate, 0.15 M Sodium Chloride, pH 7.2, 1 % (w/v) BSA, Protease/IgG free

Preservative: 0.1 % (v/v) ProClin 150 – *Use of Sodium Azide will inhibit enzyme activity of horseradish peroxidase*

Reconstitution: Rehydrate with 1.1 ml of deionized water. Allow reconstituted product to stand at room temperature for at least 30 minutes prior to dilution. If necessary, centrifuge to remove any particulates. Prepare fresh working dilution daily.

Storage: Store lyophilized material at -2-8 °C. For storage at -20 °C after reconstitution, dilute with an equal volume of glycerol to prevent loss of enzymatic activity. Prepare working dilution prior to use and then discard.

Shelf Life: 1 year from date of receipt

Specificity: Based on IEP, this antibody reacts with:

- heavy chains on Human IgA + IgG + IgM
- light chains on all Human immunoglobulins

Cross Reactivity: Based on IEP, no reactivity is observed to:

- non-immunoglobulin Human serum proteins

Country of Origin: Goat antiserum was obtained from healthy animals of US origin and under the care of a registered veterinarian.

Applications: This conjugate is suitable for use in: ELISA, WB, IHC, CL. The optimal working dilution should be determined by the investigator. Suggested starting dilution(s):

- 1:20-1:2,000 for most applications

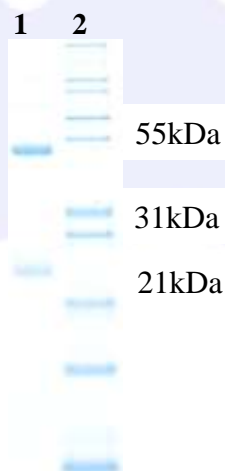

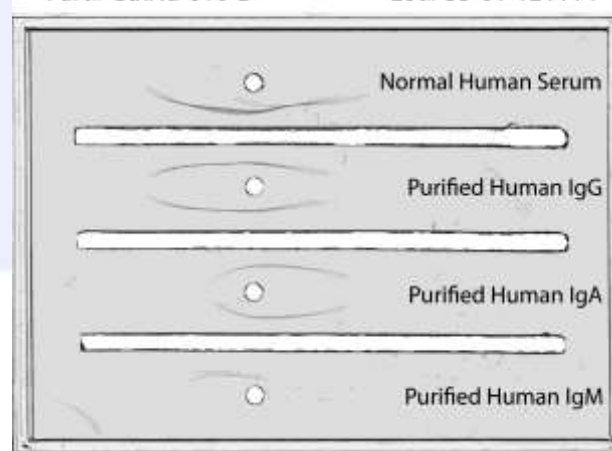
