Storage: Store undiluted liquid at 2-8 °C. Prepare working dilution prior to use and then discard.

Shelf Life: 1 year from date of receipt

- heavy (γ) chains on Rat IgG
- light chains on all Rat immunoglobulins

Cross Reactivity: Based on IEP, no reactivity is observed to:

- non-immunoglobulin Rat serum proteins

Country of Origin: Donkey serum was obtained from healthy animals of US origin and under the care of a registered veterinarian.

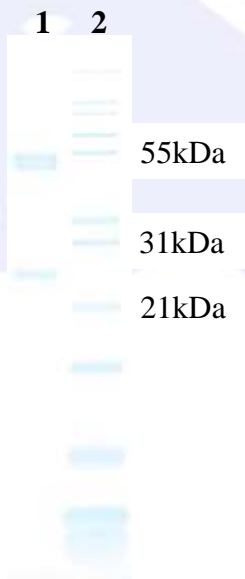

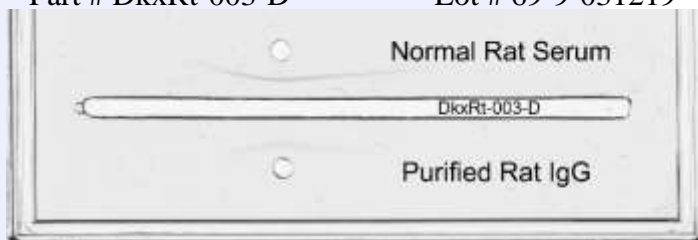
