Reconstitution: Rehydrate with 1.1 ml of deionized water. Allow reconstituted product to stand for at least 30 minutes at room temperature prior to dilution. If necessary, centrifuge to remove any particulates. Prepare fresh working dilution daily.

Storage: Store lyophilized material at 2 - 8 °C. For long term storage after reconstitution, dilute with 50 % glycerol and store at -20 °C as a liquid. Prepare working dilution prior to use and then discard.

Shelf Life: 1 year from date of receipt

Specificity: Based on IEP, this antibody reacts with:

- heavy (γ) chains on Rabbit IgG

Cross Reactivity: Based on IEP, no reactivity is observed to:

- non-immunoglobulin Rabbit serum proteins
- light chains on all Rabbit immunoglobulins

Country of Origin: Goat antiserum was obtained from healthy animals of US origin and under the care of a registered veterinarian.

Applications: This conjugate is suitable for use in: ELISA, WB, IHC, CL. The optimal working dilution should be determined by the investigator. Suggested starting dilution(s):

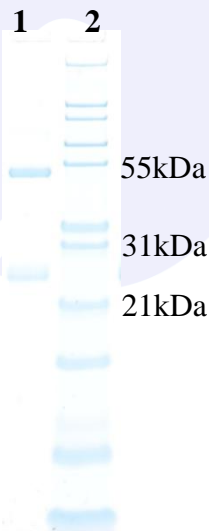

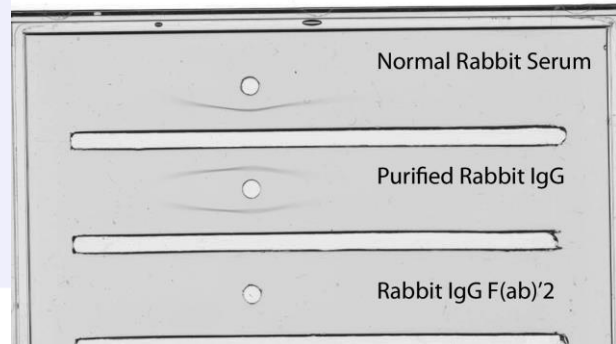
