Reconstitution: Rehydrate with 1.1 ml of deionized water. Allow reconstituted product to stand at room temperature for at least 30 minutes prior to dilution. If necessary, centrifuge to remove any particulates. Prepare fresh working dilution daily.

Storage: Store lyophilized material at 2-8 °C. For storage at -20 °C after reconstitution, dilute with an equal volume of glycerol to prevent loss of enzymatic activity. Prepare working dilution prior to use and then discard.

Shelf Life: 1 year from date of receipt

Specificity: Based on IEP, this antibody reacts with:

- heavy (γ) chains on Rabbit IgG
- light chains on all Rabbit immunoglobulins

Cross Reactivity: Based on IEP, no reactivity is observed to:

- non-immunoglobulin Rabbit serum proteins

Country of Origin: Sheep antiserum was obtained from healthy animals of US origin and under the care of a registered veterinarian.

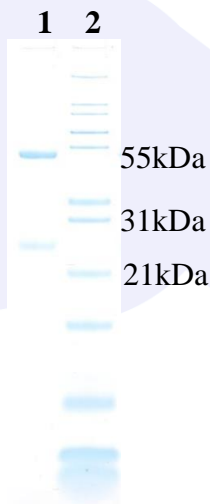
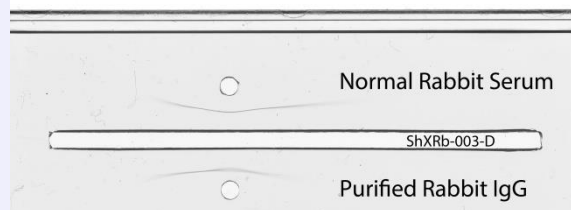
